080609 **District Councillor's News.**

District Councillor Jones was unable to attend the meeting but sent the following report which was read out by the chairman: -

District Council wise, not much has gone on since last month. The Revised Scheme of Delegation is ongoing, with deliberations between officers, the Cabinet Member and the Planning Advisory and Strategy Panel (PSAP) taking place. There will be a Policy Seminar on the subject for District Councillors at the end of July, and then a revised scheme will go to Scrutiny in September, then it will come to full Council in November. At the Policy Seminar, it's my intention to ask that all Parish Councils are notified in writing of the new proposals, not by email, as some PC's didn't receive the last lot, for their observations. The Council Meeting on Thursday this week, the main item is to approve the accounts, and then to do some housekeeping.

110609 **Stroudwater Canal**

Clerk to contact Land Registry concerning the boundaries for Rectory Cottage/ National School at Framilode.

Councillor Griffiths suggested that the Parish Council should seek the advice of a solicitor concerning implications for the future regarding the canal. Clerk to contact Parish Solicitors.

A parishioner has asked that as the water levels are low in the canal that water is pumped in. The decision was made not to do this pending engineers report regarding the work to be actioned.

Long term plan 120609

Chairman Meredith has been on another Chairman's training course.

Chairman asked Councillors to have a think about any specific goals or aims they may have for the parish and report back at the next meeting. For example, the removal of the ivy hiding the wall from Fretherne Bridge to Saul, or daffodil planting on verges.

Long term plan and Village plan to be put on the agenda for next month.

130609 Bus shelter

Clerk is to organise a meeting between the diocese, architect, parish council and SDC planning department regarding the Lych Gate.

140609 Standing orders

Clerk to forward existing standing orders to councillors. Standing orders to be put on agenda for next month.

150609 Information Exchange

Councillor Skeats will attend the good councillors' course.

A complaint has been made concerning the "bogginess" of footpath EFL14. This is due to underground natural springs. Footpaths and the land owner have been contacted.

Code of Conduct Training –information to be passed to Councillor Skeats as the only councillor not to have attended this course.

Loft Lagging meeting – Councillors unable to attend but would like further information if possible.

CPRE AGM – Councillors unable to attend.

Highways require snow warden/snow plough operators update. Passed to Chairman Meredith as he is the snow warden. This would be a good opportunity to ask for a snow plough.

Councillor Griffiths wanted to know if there were any developments concerning Lakefield School admissions. Clerk to contact the school and the governors for feedback.

Councillor Griffiths highlighted that lottery funding is available to revitalise a village if a project is necessary. Details passed to the site regeneration committee.

160609 Public Forum

Councillor Findlater has had concerns raised over the footpath by the church. Councillors to clear when possible.

Mr. Ron Hartell will put up "no tipping" signs in the Church Lane area of Gardeners Pool in an effort to stop grass cuttings etc. being tipped over the hedge into this area.

Clerk has received an e-mail from a parishioner which the chairman read out. The main concerns were the rubbish bin overflowing in the playing field area (clerk has contacted SDC and this will be emptied), a photograph of the residents house on the parish website (this has been removed), the maintenance of the pump (clerk to contact IDB) and cows on footpaths, who is responsible for them (clerk to pass on this query to footpaths).

Mrs. Gardner asked if priority arrows could be put in place at Sandfield Bridge. Highways have recently told councillors this is not a possibility. Councillors to monitor the "keep clear" boxes to see if this alleviates the traffic difficulties in any way.
