At the District Council elections held on 7th May, the Conservative Group gained 2 seats from Labour, giving them a total of 23, and still being the largest political party at the Council, but not enough to have an overall majority. At this stage, it is expected that the current arrangement of the existing Alliance of Labour, Green and Lib-Dem parties will continue to run the Council, which has a total of 27 seats, with 1 "Conservative No Group" member.

#### 090515 Stroud Water Canal

Cllr S Harrower attended focus group 2 weeks ago. The presentation by CRT was of good quality. The first meeting was held on Thursday 14 May 2015. Cllr S Harrower attended this. Oher attendees were from Frampton on Severn (William Alexander); Highways (Dan Tiffney); 3 x CRT representatives, Inland Waterways.

Topics discussed covered bridge protocols, parking by Sandfield Bridge and the turning for the Stables Café. One of the suggestions is a mini roundabout. Sandfield bridge is one of the most difficult and busiest bridges for CRT to choose to automate first. CRT only have control of the bridge and highways are responsible for the roads. CRT are prepared to say the bridge has to be open for traffic at certain times (i.e. work morning and evening traffic). CRT have land that could be used for parking for long term boaters etc.

The emergency services are all on board. The automation of bridges will make it easier for them as they will only have to contact one main control number instead of individual bridge keepers. There will be an intercom on each bridge so that the control centre can be reached.

Nick Worthington was at the public meeting and the first meeting on 14 May 2015 and confirmed that CRT, Highways and Parish Councils will all work together. Church Lane is a major problem with parking on the roadside causing obstructions. One idea would be to package all the bridges together for yellow lines etc to control roadside parking although this would still need policing.

The sensor on the bridge could be blocked and cause the bridge to be unable to

be opened if for example a large goose was sitting by the sensor.
