If it is, then either the pc or the district council will have agreed legally to undertake the maintenance.

A church with an active burial ground is not the responsibility of the pc unless an agreement is in place for the maintenance, recognising that there is value to the community. This agreement may be lost in the mists of time. Perhaps the PCC can provide a document to this effect if you are unable to locate one.

If it turns out that the pc does have the responsibility, then it will need to budget for the work.

Road signs - council to consider whether to proceed with the purchase of replacement signs by Cadbury Bridge, Sandfield Bridge and the entrance to the village in Moor Street.
