060415 District Councillor News

The District Council AGM will take place on May 21st, when the make-up of all Committees will be agreed and the Council Chair and Vice Chair elected. DC Jones advised that, at the last meeting on 9th April, authority was given to the head of finance and head of asset management to borrow money which will be sufficient for waste collection vehicles, repair and storage of ancillary vehicles eg grass cutting equipment, sweeping etc. There will be a building for the transfer of recyclables and food waste which will be coming into place in July next year. There will be sufficient space for storage, sorting and removal onwards every day. A planning application for this depot is awaited. The Council are spending money to fight the Javelin Park incinerator, going to partial judicial review.

At the Severn Voice meeting canal bridges, fish and eel pass, school admissions and boundary reviews were discussed. There is a SV sub group meeting to be held on 20 May 2015, to further consider the School Admissions issue. 2 representatives from each parish council in the Severn Voice Group will form a focus group to join with CRT to make sure the boaters' app to open Canal bridges works properly. The fish and eel pass at Framilode is currently on hold.

#### **Stroud Water Canal**

A consultation meeting was held on Monday 27 April 2015 which was attended by Severn Voice, Parish Councillors and Inland Water Association. There was a presentation by CRT with a team of technical expens supporting. The general public raised concerns about the emergency services and the response was that there will be significantly improved mechanisms for the emergency services to contact the control centre to ensure the bridge is open. The bridge opening and closing cycle by boaters using their apps could be improved from the current timings. If there was a queue of boats coming through, there will be a maximum opening time. This will be dependent upon the time of year, seasons etc. An embargo period on rush hour traffic at busy crossings will be looked at but will be part of the overall concept.

There was concern raised that the apps could be abused by hackers but each app will be monitored by the control centre and will only be available to licensed boaters. If a boater does not have a mobile phone installed with the app, there will be an alternative way of contacting the control centre via VHF radio or mobile phone.

CRT believe it will be able to manage the traffic although admit it is a complex issue. The automatic opening of Sandfield bridge will commence in Summer 2015, bridges north of Fretherne complete by December 2016. The quay and Sharpness bridges will be an exception. There will be focus groups set up for specific bridges to monitor issues, road traffic and boat management. There will be councillors on the focus groups. There will be leaflets available giving more information sent out to householders north of Sandfield bridge and also one pinned to the notice boards. There will be a survey carried out at some point to cover concerns raised.

There will be CCTV monitored by the control centre which will cover approach roads for intelligence when there are issues.

To date on Sandfield Bridge there have been 4,500 successful openings carried out by the bridge keeper on his mobile phone. Each bridge will have its own wi-fi area so it will not be phone dependent.

Each bridge will retain a unit for manual opening but there is a query on whether the bridge keeper's huts will be dismantled.
