090608 **District Councillor's News.**

District Councillor John Jones reported the following:-

There is to be a special meeting concerning the canal project – council decided to apply to the Heritage Lottery Fund to become the lead partner in the project as British Waterways have pulled out. The decision will be known early next week. Another Council meeting will take place to decide how to source additional funds if it becomes necessary.

There will be a council meeting tomorrow night with a few items on the agenda:-

Annual report of the Standards Committee – how the national standards committee are delegating authority to local standards committees.

Statement of accounts – Council has to adopt the statement of accounts 2007-2008 by 30th June

Independent Remuneration Panel Report – currently District Councillors are able to claim mileage for any number of parish meetings they may attend in the year. There is a recommendation that councillors who attend parish council meetings as a district council representative may only claim for a maximum number of 12 visits for the whole ward for the whole year.

There are 3 motions to be discussed –

The procurement of rain harvesting facilities (for example a fully costed rain water harvesting system could save approximately £2500 if rain water is used to flush toilets) District Council to pay its share of the costs of Gloucestershire Accounts.

Waste Strategy Advisory panel -10 councillors will assist in devising and formulating a robust waste policy.

Councillor Linda Griffiths asked DC Jones for clarification on the parish boundary for the conservation area extension plan as it looks like (according to the plan) that part of Fretherne with Saul Parish is listed as Frampton Parish. Councillor Griffiths and Councillor Meredith will liaise on this item.
