Minutes of Fretherne with Saul Parish Council meeting, held by Zoom due to Covid 19 restrictions, at 7:30pm on 27th January 2021.

050121 Introduction to Harriett Osburn, Highways

Harriet sent her apologies as not able to attend.

060121 To receive report from County Councillor Stephen Davies.

Noting that during this lockdown there is greater impact on both county and district councils, this is due in part to higher rates of Covid, need for home schooling amongst others. Staff continue to work from home.

County vaccinations are ahead of most of the country but caution is still needed.

County Council have allocated additional £200k to buy another laptops for children to assist with home schooling and also continue to support the no child goes hungry scheme providing meals whilst schools are closed during February half term.

Fire and Rescue have had an inspection during the Covid, they have reacted well to the demands with the fire service driving ambulances.

Council have initiated a kick start program to help particularly 16 – 24 year olds on universal credit to get to work. Covid has disproportionally affected young people in jobs.

Budget has been published for the next year with investment details are online along with the opportunity to comment on the budget.

The council has launched a scheme to replace any tree suffering from Ash die back, applications are on line.

Most SDC staff still working from home, and likely to do so for the foreseeable future.

The determination of Planning Applications is lagging behind still, there are some new staff in the department, hopefully will improve.

SDC is to review and develop a Leisure, Health and Wellbeing Strategy, which is aimed at improving lifestyles and helping the area to recover from the pandemic, as things get better, (we hope).

Applications to the Community Resilience and Wellbeing Grant Fund close on Friday this week, any voluntary organisation that is struggling financially can apply to see if they are eligible, in the first place, before applying to the Fund. Details can be found on the SDC Website

There is a planning application in by Smiths of Eastington to fill the old gravel pit behind Fromebridge Service Station with 57,000 cubic metres of soil of varying grades. I, with support from Cllr Davies, and FoS and Eastington PCs have called it in to Development Control Committee for determination, on possible flooding and road safety issues.

090121 To discuss any correspondence received

Emails from resident with regards to future possible development of Fretherne Nursery site, the Council advised that at present nothing has been formally submitted and, at this stage, there is nothing to be acted on. There was no information to be passed on at this stage.

Report, by a resident, of a man removing fish from the disused canal at Framilode. Environment Agency emailed details of bylaws which if contravened they would consider becoming involved. Two bylaws were being contravened –

- You can use live bait using a small fish to a catch bigger fish providing that the bait fish is retained at and used only in the water from which they are taken, except where local byelaws prohibit this.
- It is prohibited to move any fish, alive or dead or any other creature or plant life from one water to another, as this can spread diseases.

This is noted should there be any other instances of fish removal happening. Need signage to say Private and no fishing allowed. To be discussed further at next meeting.

Action: Cllr C Bartlett to contact Water Bailiff re support with this.



Email from resident regarding water levels around Hells Corner area. The level of flooding and standing water around Hells Corner and between there and Malt House Farm is of concern, Highways have investigated the drain and found that the pipe has been damaged possibly as a result of work during fibre installation. Drains continue around the corner, past Hoopers Farm, Lion House to the village. Further investigation is needed into drainage issues.

Water levels / flash flooding through the village over the past weeks were included in this discussion, in particular the 23rd December, including the pump capacity. Could the Council have o.o.h. tel numbers for pump company? Church Lane surface ditches have been cleared but are the culverts clear? Need a flooding / water level survey carried out to make sure that water flows through the parish and not cause floods. Person at County to be contacted re possibility of including the parish in flood assessment.

Dist Cllr Stephen Davies left the meeting at this point.

A proposal to formulate a village floodplan was made. Identify people who could respond, sand bag availablility, storage. To be carried forward to the next meeting.

Crime statistics for the six month period prior to the 24th January 2021 are 37.5% up on the same period in the previous year with 11 recorded crimes. The largest crime over both periods was Assault causing injury.

PCSO M Trebble and the SDC Neighbourhood Warden have visited the local playgroup and walked around the village and up towards Sandfield Bridge.
