Public Question Time

Three questions were presented to the council, what has been the legal costs incurred to date by the PC in relation to progressing an easement right over the land? Who are the third party that have recently been made reference to who are financially contributing to the appeal process, their level of contribution and how/when was this agreed? What is the protocol for dealing with matters under confidentiality/closed meetings? These questions are all pertinent to either the ongoing legal case or having direct bearing on the letter of complaint or requests made under the Freedom of Information request that has already been sent to the council. The clerk reminded the Chairman that as a point of order, questions raised in public questions time could not be answered immediately but had to be discussed at a later date by the whole council before responding. The Chairman responded to the questions by advising that the points raised had been duly noted and would be considered by council.


To receive a report from County Councillor Stephen Davies

Had a County Council Election - the result was Conservatives won 28seats, Liberal Democrats 16, Labour 5 and Greens 4 which means the County Council remains under Conservative control.

I have to say personally, and I was watching the boxes being emptied at the count, when you see your name on the ballot paper and you see people put their cross against it most don't even know who you are, it is incredibly humbling and does remind you that you are actually here to serve people and I always find it a very moving experience to be re-elected.

The good news is that we are back and re-elected and there is a council in place it means we can continue with things like Highways Local, so we are now ready to make decisions on where we will be spending money on roads and making investments in that area. And the other thing I have been doing a lot of work on is schools, there is an issue here around secondary schools especially in Arlingham as they are the furthest away from Severnvale and this means they miss the catchment area for Severnvale, they missed it two years ago as well. That leads to all kinds of issues although I have to say although they missed the catchment area only two of the children in the village applied for Severnvale and the other 20 something applied somewhere else. The long term solution to this is another secondary school and the Department of Education have signed up to build us a new secondary school, they are now looking for a location, one suggestion has always been Whaddon which I oppose

because I think it is too far away. I do believe there'll be a site somewhere closer and better and will continue to work on that as we go forward. The other solution to this, which I am trying to do some work on, is I am trying to arrange a meeting with the headmaster of Rednock School, which has been slightly delayed as I am sure you know they had a tragic incident which they are coming to terms with at the moment so that meeting has been delayed. I don't know why, or how, but I am going to try to persuade them that they should put this part of the world in their catchment area. That has the effect that it increases the chance of children getting selected for Rednock but it also means, because we are more than three miles away from Rednock, would provide free bus transport; because much of this issue was raised when the bus charges were changed then you had to pay for every child that used it. So I am working on that as a solution to that. I have no confidence that I can find reason why we might persuade them to do that but at least we are going to start that conversation to see if we can find out any common ground on that. So I will keep you updated, I'm not making any promises but I am working on it. The other thing I want to talk to them about, because I have learnt a lot in the last couple of months on this is that I thought County Council controlled the buses but it doesn't. Actually, these academy schools run their own bus service so they contract it out and the concern locally is that we've seen one change in the bus charging, actually it's not increased but it technically has because you now have to pay if you don't go on the bus, previously you had a token and if you stayed for an after school club or you got a lift you didn't pay for the bus. The worry at the other end is that we have seen bus charges increase and that's at the discretion of the academy, so again I want to talk to the head about any agreements they can make about controlling the increase in bus fares going forward.

So then the next thing I wanted to move on to report back on, we have full council tomorrow so next meeting undoubtedly I will have lots of interesting things to update you on.

Stephen and John would like to thank all who voted to put them back at Ebley Mill, as District Councillors for Severn Ward of SDC, in the recent elections. The results of the recent elections mean that no one political party has overall control of Stroud District Council, so the Alliance of Green, Labour and Lib Dem parties looks set to continue. Labour 15 seats, Green 13, Lib Dem 3, Conservative 19, Conservative Independent 1

The Draft Local Plan was approved by a majority decision at the full Council meeting on April 29th. This means that no land put forward in the extra consultation towards the end of last year in Moreton Valence or Whitminster parishes were included in the Draft. It will now go for a public consultation in June and July for six weeks, with adjustments coming from that consultation being made, before it goes for the Examination in Public by a Government Appointed Planning Inspector. This is where the parcels of land not included in the Draft, and some that were included, will come under extreme scrutiny by Planning Barristers and Agents employed by developers and opposing groups, arguing the case in front of the Inspector for respective parcels to be included, or taken out. The Public Examination is expected to start in the autumn of this year, with a final Local Plan being ready for adoption later in 2022.

The planning application for the Solar Farm at Moreton Valence and Whitminster has been submitted, Application Ref S.21/0465/FUL applies. There are many letters of objection that have been registered.


