EM040721 To discuss an offer made with regard to the easement application presently with the land tribunal and to make a decision on the suggested waiving of costs by the other party.

Following an explanation of the situation to date and the terms of the offer which has been received from the other party via Birketts, a discussion took place as to whether the parish council should accept or reject the offer in its current format. The parish council also discussed what terms would be acceptable including the minimum costs. It was agreed the offer, in its present form should be rejected, an counter offer would be sent via Birketts outlining the minimum acceptable terms, these being unrestricted access to the churchyard and minimum payment of £10,000 nett costs. The parish council is mindful of the time constraints with the appeal hearing imminent.
