Communications have been received from a member of the public, two have already been responded to with a third soon to be answered.

#### 121121 Clerks Report

Feedback from items raised at the last meeting -

The amount the clerk is able to spend, with the Chairman's approval is £500.

The branch stuck at the weir at Framilode moved down river to the flood gates and has since been removed by the Environment Agency.

A letter has been sent to the member of the public who wrote with reference to a previously submitted complaint.



The earlier planning application for Frome House has been checked and confirmed that the application was approved for a drive to the rear of the property.

SDC have provided the link to the rubbish bin supplier. This has been circulated to the PC and the Memorial Hall committee for future discussion.

The bunkers for possible storage of sand and sand bags cost £378 ea inc VAT with a lead time of approx. 3 weeks.

Historical documents have been provided to ClIr Bierer regarding the purchase of the Framilode section of the Stroudwater Canal.

131121 To receive an update on the register of The Ship public house as a Community Asset.

The five year listing of The Ship as a Community asset is due to expire in August 2021, this has been resubmitted. Cllr Bartlett to advise.

141121 To receive an update on the repair and maintenance of the phone box/defib housing.
